RULES OF THE SCARBOROUGH RIFLE CLUB

1. The Club rules, instruction signs and light signals are to be obeyed without exceptions.
2. Range Officer has full and complete authority over persons and activities conducted on the range.
3. All persons on the firing line must wear hearing and eye protection.
4. Members must not touch or handle rifles unless specifically instructed or allowed to do so by the Range Officer or member's shooting coach.
5. Only rifles approved by a Range Officer can be used on the SRC range. Only .22 rim fire **single shot sporting rifles, match rifles, and air guns** are allowed in the range area. Any other type of shooting equipment must not be brought to or used in the range.
6. Members who wish to use their own firearm(s) and/or ammunition on the SRC range must be in possession of a valid license (FAC or PAL or POL) and present it to the Desk Officer when requested to do so. **Unlicensed members are strictly required to use rifles and ammunition provided by the Club.**
7. No rifle is to be loaded until the command to do so is given by the Range Officer.
8. Action must remain open except when a rifle is actually being fired.
9. When a **cease fire** is called, all **actions must be opened** and firearms **unloaded** immediately.
10. Any inoperative rifle must be reported to a Range Officer and immediately removed from the line.
11. Any member not answering calls for three consecutive squads may have to forfeit that day's / evening's shooting.
12. Club scopes are to be used by shooters or range staff only.
13. Club equipment is for use of all members of the Club. Any member mishandling or damaging such equipment may have this privilege withdrawn.
14. A Range Officer must always be present on the firing line at the beginning and during shooting.
15. Only Range Officers and authorized members of the Executive are allowed access to the Club's storage areas.
16. **Members not shooting are required to refrain from carrying on loud conversations, which may be distracting to those on the firing line.**
17. Privately owned equipment is not to be handled without permission of the owner.
18. Anyone showing the slightest sign of being under the influence of alcohol or drugs will be immediately required to leave the range.
19. Club membership card must be presented to the desk Range Officer upon entering the club, and must be worn in visible location during attendance at the club.
20. Smoking is not permitted in the building.
21. Violation of these rules should be immediately reported to a Range Officer, the Chief Range Officer or any member of the Executive and it may result in suspension of the member or his/her dismissal from the Scarborough Rifle Club.
